Do you need to submit a schedule 1, 2, and 3 along with your 1040 Tax Return?

You may have **one** or **multiples** of the below schedules to submit.

- Is there an amount on your 1040 in line 6? You will need to submit the schedule 1 along with your tax return.
- Is there an amount on your 1040 in line 11 box 2? You will need to submit the schedule 2 along with your tax return.
- Is there an amount on your 1040 in line 11 box 3? You will need to submit the schedule 3 along with your tax return.

Please see the 2 pictures below of a 2018 IRS 1040. Highlighted are the fields that need to be checked for an amount, to identify if they are applicable to you.
